FT 12+ credits: \$8,400

PT 5 or fewer credits: \$820 per attempted credit

Tuition charges are separate from program fees.

Program Fees:

Learning Management System Fee: \$200 per term

Technology Fee: \$450 per term

Program Resource Fee: \$600 in term 1; \$100 per term (Terms 2, 3, 4, 5, and any additional terms)

Clinical Placement Fee: \$150

Book Fee: \$220

Book charges are posted to the student ledger individually in the term in which the corresponding course is scheduled.

Total Estimated program book cost: \$1,161-\$1,309

The estimated total cost of books for this program includes:

- A required \$220 book fee charged by MCC (listed above), which covers e-books and course materials provided by the college; and
- Estimated additional book costs for required books and materials that students must purchase separately from third-party vendors.

The estimated cost of books purchased outside of MCC is based on current pricing and is subject to change. Actual costs may vary depending on book editions, book format, course requirements, vendor pricing, and purchasing options.

Estimated dosimetry badge fee: \$100

Students participating in clinical externship as part of the AAS in Diagnostic Medical Imaging Radiography program may be required to wear dosimetry badges whenever on site. MCC will issue the badges to students as needed, but the students are responsible for covering the costs for the duration of the clinical assignment. The fee is estimated and is subject to change. If the badge is not returned to MCC within 2 weeks of becoming inactive will be charged a non-return fee of \$50.



Additional out-of-pocket program costs may be incurred. Additional external fees are not paid directly to Midwestern Career College (MCC). All costs are estimated, and prices are subject to change without notice or MCC's knowledge. Examples include, but are not limited to the fees to cover the cost of vaccination, drug screening, physical exam, and additional background check, among others that may be applicable. Estimates below do not include costs for travel to and from school and clinical education site, site-specific vaccination and drug screening requirements, site-specific uniform costs, or any other additional costs imposed by clinical sites, certification, and/or credentialing agencies among others. Students should also refer to the catalog and their enrollment agreement for more information on program specific and/or administrative fees.

Criminal background check:

The cost of the first background check is covered by MCC during admission process. Depending on the timing of externship placement and clinical site's policies, students may be required to undergo additional background check(s) which is covered by Castle Branch Subscription.

CPR Training:

Limited CPR courses are offered free of charge by MCC for students enrolled in allied health programs. CPR course enrollment is subject to course capacity and seat availability.

Certification Reimbursement Policy:

The Associate of Applied Science in Diagnostic Medical Imaging Radiography program offers reimbursement opportunities for the following certification/ licensing agencies:

- ✓ American Registry of Radiologic Technologists (ARRT) Radiography (R) exam

MCC will reimburse the cost of the certification exams listed above once per the certification attempt. To qualify for reimbursement students must:

- Pass the program exit exam or certification preparation exam, if applicable;
- Receive written approval from the Program Director or designee before applying for the certification exam;
- Attempt the certification exam no later than 180 days from the program completion date;
- Provide a copy of the certification exam results (passing or failing) to the Program Director or designee within 14 calendar days of taking the exam or within 14 calendar days of the receipt of the certification exam results, if the results are not available immediately;
- Provide a copy of payment receipt to the Program Director or designee;
- Be in good academic, financial, and conduct standing with the college at the time of reimbursement.

If certification exam cost changes, MCC will reimburse the student up to the amount listed on this disclosure, but not higher than the actual cost of the certification exam as paid by the student. MCC will not reimburse for the certification exam costs paid by third parties. If a student has an open balance with the college, the certification exam reimbursement will be applied directly towards the student's open balance. If a student does not have an open balance with the college, a check will be mailed to the student's address on file with the college, unless other arrangements are made in advance with the Business Office. The policy may change with or without notice.

Explanation of Clinical Course Charges:

Clinical course tuition is \$2,800 per 270-hour clinical course.

The program requires three (3) clinical courses, for a total of 810 on-site clinical hours.

Under the standard program sequence, Clinical Courses 1, 2, and 3 are typically scheduled and charged in Terms 3, 4, and 5, respectively. Under this standard sequence, clinical course tuition is included in the overall tuition charged for the terms 3, 4, and 5.



However, clinical scheduling may vary from the standard sequence due to student readiness, clinical site availability, or other clinical scheduling requirements.

Clinical scheduling rules require that the credit load for a clinical course be assigned to the academic term in which the majority of the clinical hours for that course are scheduled to be completed. As a result, and depending on when clinical rotation begins, more than one clinical course may be assigned to the same term.

When this occurs, the clinical course tuition may be posted to the student ledger as a separate tuition charge to ensure charges are applied to the academic term in which the clinical course is assigned.

If two clinical courses are assigned to the same term, the tuition charge for one of the clinical courses may be deferred and applied to the following term.

Under normal circumstances, the combined tuition charges for didactic coursework and clinical course(s) will not exceed \$8,400 in any single term. Exceptions may occur if additional didactic courses are required due to course repeats, retakes, or similar circumstances, and/or if tuition charges for multiple clinical courses must be applied in the same term.

Cost of Attendance 26/27 Award Year

Cost of attendance (COA) is the total estimated cost of attending a college or university per academic year. It includes tuition and fees, housing and food, books and supplies, transportation, personal expenses, and other education-related costs. Colleges use the COA to show the estimated total cost of attendance and to determine a student's eligibility for financial aid. The COA is used as a planning and financial aid tool and does not necessarily represent the actual cost of the program.
